1. SUMMARY

The project started in September 1996 with the design phase. Logging of injection boreholes, pipeline design and design of pumps were completed during the first 6 month period while something was still left of the design of seismic monitoring equipment.

The manufacturing phase started in November 1996 by production of pipes followed by the pipeline construction of which about 30% were left by the end of the period. Modification of seismic software was initiated but not finished.

In general the progress of the project is very much in line with the time and cost schedule of the contract and no major deviations have occurred yet.

2. PROGRES REPORT

2.1 Introduction

The structure of the following progress report is based on the items described in the detailed breakdown of the project in table 21 of Annex I of the contract, but with minor deviations.

The work on the project started in September 1996 and the progress until end of February 1996 is described. On next page a progress diagram for the project is shown.

2.2 Design

2.2.1 Overall design of the project

This part was already more or less finished during the preproposal phase. The overall design was reviewed in connection to the more detailed design of individual parts of the project but it has only minor changes from the original design. The overall design of the project is under constant re-estimation during the progress of the project.

2.2.2 Logging

The first logging phase of the injections well were completed during the autumn 1996 under responsibility of Orkustofnun. The logging included sonic logs, resistivity logs and borehole televiewer as well as several other conventional logs.

2.2.3 Pipeline design

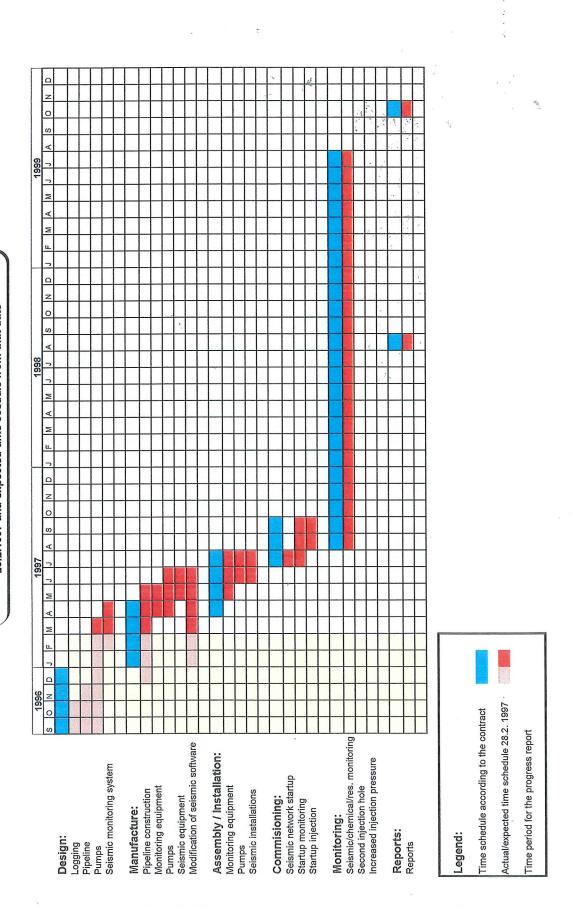
The general specifications of the pipeline was finished in October 1996 and detailed design of the pipeline as whole in November 1996. The design work was carried out by technical department at HVA with assistance of consulting engineers.

2.2.4 Design of pumps

At the end of February 1997 the design of pumps for the reinjection system was finished. The design work was carried out by technical department of HVA in co-operation with Orkustofnun, Rarik and consulting engineers.

2.2.5 Design of seismic monitoring system

The design of the seismic system started in Dec. 1996 and was not finished by the end of February 1997. The design is in the hands of the University of Uppsala in co-operation with Orkustofnun and HVA. It is estimated to be completed in May 1997.

Site investigation in the Laugarland area in the respect of seismic monitoring was performed in January 17th. Good bedrock can be found on hillsides west and east of the river Eyjarfjardara but the flat bottom of the valley is covered by thick sediments with unfavourable conditions for precise detection of high frequency seismic signals. The valley bottom should therefore be avoided in site selections.

Genetic Algorithms have been used to invert for the best location of the six stations. The results show very strong dependency of the exact location of the closest station. Five of the 6 seismic stations will be located on the hill sides and there it should not be any problem to find good places for the seismic sensors. For the remaining station, which will be the closest station to the production and reinjection wells, further site investigations are needed. This station should be placed as close to the injection well as possible without getting too much noise from the production pumps or the injection facilities.

To find a suitable site for the closest station, noise tests will be carried out in March or April in order to record the ground motion from the production pumps which can produce large signals especially close to the resonance frequency. When the exact location of the closest station is found we will use the Genetic Algorithms to get suggestions for locations of the remaining stations. The criteria used in the inversion is maximising the variance of the: a) distances up to 3500 m, b) angles from the source to the stations, and c) the angles within a quadrant modulus.

Contacts will be established with the National Telephone Company P&S to get information about the availability of telephone lines in the area. The type of connection we are seeking can range from: a) simple modem connection, b) X.25 connection, c) Internet subscription or d) ISDN connection. The minimum speed of the connection should be 2400 baud, but higher speeds are desirable. We will just select the alternative with the best price-performance ratio that can be obtained.

2.3 Manufacture

2.3.1 Pipeline construction

The manufacture of the pipes for the 12 km long pipeline for return water from Akureyri to Laugaland were completed in early December 1996. Hochest Danmark was responsible for this part of the project with aid of a subcontractor, Set hf.

A open tender for the construction of 8 km of the pipeline was launched in Dec 1996, the remaining 4 km are to be constructed by the own staff of HVA. A total of 5 contractors

made bids. The lowest bid was accepted and a subcontract was made in Dec 1996. The lowest bid was 38% of the expected price while the highest one was 83% of the it. This unusual low prices are due on low activities among contractors during the main winter season.

The pipeline construction started in late Dec 1996 and by the end of February 8 of the 12 km were finished in spite of difficult climatic conditions in February.

2.3.2 Monitoring equipment

Not started by end of February 1997.

2.3.3 Pumps

Not started before end of February 1997.

2.3.4 Modification of seismic software

During December '96 and January '97 work has been focused on software development related to the interfacing of the Nanometrics HDR digitizer to the SIL Utility Software. Tests have been performed for 500 samples per second on three channels using Pentium computer. Results show a good performance although approximately one second of data is lost during 24 hours of operation. The reason for this is still under investigation questioning if this is due to problems within the digitiser or the software handling of the incoming data.

During the next three months, work will be concentrated on adaptation of the phase-detection procedure to the 500 cps configuration and the higher frequency content of the data. Adaptation of the rest of the seismological software is planned to be worked on during April and May '97.

2.3.5 Seismic equipment

After the design phase of the seismic monitoring system the components of the seismic stations will be purchased from various producers, assembled and installed. This is estimated to take place in April to June.
